Which devices can be used for Computop PhonePOS?

Commercially available, Android-based smartphones and tablets (COTS devices)

The application is available for download in the Google App Store. A newer generation Android device (Android version 11 or higher) is required.* The device must meet the continuous minimum requirements and must not be rooted.

Enterprise handhelds (Professional devices)

The use of Android-based devices developed for professional purposes (e.g. for logistics or catering) is generally possible. However, feasibility must always be assessed individually and requires a customized project offer.

Who can use Computop PhonePOS?

Consulting-intensive retail

Let your customers pay immediately after the consultation on the shop floor, with no need to queue at the checkout.

Examples: Consumer electronics, home and living

Mobile services

Save your field staff from having to carry extensive hardware and let them accept card payments via their mobile devices instead.

Examples: Customer services (installation, maintenance, repair), logistics (parcel services, trucking companies)

Enable the flexible sale of goods at changing, non-permanent points of sale.

Examples: Stadiums and concert halls, festivals, gastronomy

Included PIN functionality for high purchase amounts


For payments exceeding €50, shoppers enter their card PIN directly on the PhonePOS device in a secure environment. Payments under €50 do not require a PIN to be entered.

The amount of €50 refers to the NoCVM limit applicable in Germany.* If the limit is exceeded, the cardholder must be additionally authenticated.

Security

Computop PhonePOS is subject to the strict approval requirements of the German Banking Industry (DK) and Payment Card Industry (PCI). The security architecture of our solution features a dedicated monitoring

server, protecting the application during operation and checking every transaction in the background. Automated security updates every four weeks guarantee absolute software integrity at all times.
